Invitation for Bids for the Construction of Rural Municipality office building.

1. The Government of Nepal [GoN] has allocated funds towards the cost of **Construction of Rural Municipality office building** and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Rural Municipality office building (Contract No: BRM/W/NCB/078/79-11). Bidding is open to all eligible bidders as per Section V of Bidding Document .
2. Bhairabi Rural Municipality, Dailekh invites electronic bids from eligible bidders for the construction of Rural Municipality office building Bhairikalikathum, Dailekh under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 78 Million (Excluding VAT)
 - Minimum Work experience of similar size and nature (i.e. at least one RCC Building Construction Experience within last 10 years); Value of Service for Single Project shall be of at least NRs. 80 million (Excluding VAT) has been successfully or are substantially completed.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bhairabi Rural Municipality, Bhairikalikathum, Dailekh, Karnali Province, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's **Rajaswa** (Internal Revenue) account as specified below Information to deposit the cost of bidding document NRs. 10000.00 in the Project's **Rajaswa** (Internal Revenue) account as specified below.

6. Pre-bid meeting shall be held at Bhairabi Rural Municipality, Bhairikalikathum, Dailekh Karnali Province Nepal at 2078/12/07 13:00 hours. Electronic bids must be submitted to the office Bhairabi Rural Municipality, Dailekh, Karnali Province, Nepal by through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 2078/12/22 12:00. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2078/12/22 14:00 hours at the office of Bhairabi Rural Municipality, Dailekh, Karnali Province, Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 28,00,000.00 which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
